PROPERTY TAX/RENT REBATE PROGRAM EXPANDED!

ARE YOU ELIGIBLE?

More Pennsylvania seniors and people with disabilities are eligible for increased property tax or rent relief this year under a new law I supported in 2023.

Under the expanded program:

- Income eligibility INCREASED to \$45,000 this year for both homeowners and renters. Remember to exclude 50% of Social Security when calculating income.
 - Maximum rebate INCREASED TO \$1,000.

As always, my strict office staff stand ready to help people apply for their rebates FREE OF CHARGE. Applicants should be prepared to provide all the necessary income, and property tax or rental information required to process claims quickly and accurately. Applications are due by June 30.

The Property Tax/Rent Rebate Program benefits eligible residents 65 years and older; widows and widowers 50 years and older; and people with disabilities 18 years and older. More information is available at *RepWatro.com*.
